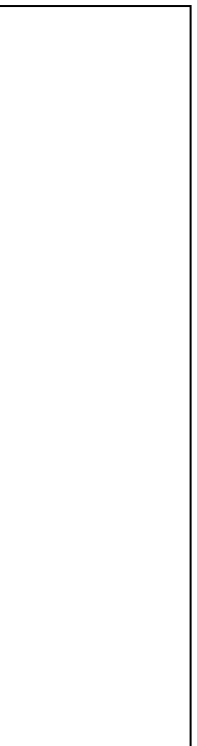

Juror – Tom Lynch

Tom Lynch has been referred to as “one of the nation’s premier watercolorists”. He was recently listed as one of the nation’s top twenty teachers by a leading art magazine. Mr. Lynch is currently represented by some of the nation’s leading museums.

Mr. Lynch’s list of credentials include: Two Lifetime Achievement Awards, Signature Membership in many national watercolor societies, election into the illustrious “Society of American Impressionists,” as well as “Who’s Who in American Art.”. He has won numerous awards and was the first American selected for Honorary Membership in the “Canadian Watercolor Society.” We are honored and privileged to have Tom Lynch as our judge.



Awards - \$4000 in cash and merchandise-awards will be given. The awards will be selected at the discretion of the Juror. Only one award per artist.

Eligibility - The SWA 29th Juried Art Exhibition is open to all artists 18 years old and over .

Works Eligible - Work submitted must be primarily water media on paper. Collage, if used, must be water media only; no commercially colored or printed paper may be used. Work must be original and not done under supervision. The work must have been completed in the last three years and have not previously appeared in any SWA exhibition. The maximum size in any direction, including frame, is 40 inches. Frames may not exceed 1 ½ inches.

Catalogs - An exhibition catalogue will be sent to each entrant, all SWA members and award donors.

Additional catalogues will be available for \$15 each, plus \$2 postage.

Signature Membership - Is bestowed on any member who has exhibited in five different SWA Exhibitions while sustaining active membership. He or she has achieved the right to place SWA after their signature.

Entries - Up to three paintings per artist; only one entry per artist will be accepted. Artists who enter as nonmembers are not eligible for Signature Status.
All entries digital CD only.

Format as JPEG files using a 300 resolution (DPI) all three artwork photos on one CD. Be sure to keep a separate copy of your CD for your records.

The naming convention for your CD file should be:

Painting #1 lastnamefirstname1.jpg
Painting #2 lastnamefirstname2.jpg
Painting #3 lastnamefirstname3.jpg

We will ONLY return your CD if you enclose a CD-sized SASE with correct postage. CD's not returned will be destroyed after 3 months.

Deadline January 22, 2010

Entries received after deadline will be returned unopened.

Sales - All sales must be arranged between artist and buyer. Artist are asked to donate 20% from works sold to SWA. So price your paintings accordingly. Paintings not clearly marked with a price will be considered not for sale

Liability and Insurance - Although SWA will exercise great care in handling works submitted to this exhibition, neither SWA, Box and Ship, nor the Fort Worth Central Library will be responsible for loss or damage to any work. Artists are responsible for loss or damage to any work, and for insuring their paintings to, from, and during the exhibit.

Framing - All work must be in neutral mats, with simple frames, wired for hanging and **under Plexiglas**. Diptychs and triptychs constitute one painting and must be framed as such still meeting the 40" maximum. Improperly framed or damaged work will not be hung. **No saw tooth hangers, No wood crates, No Styrofoam peanuts.** We recommend reusable cartons preferably Airfloat Systems or similar. Airfloat will give a 20% discount if you mention SWA: call 1-800-445-2580.

Shipping /Delivery of Artwork - Artists are responsible for all shipping costs both ways. UPS, DHL, and FEDEX may be used. **DO NOT SHIP VIA THE US POSTAL SERVICE.** Artists may prepay the return shipping costs, or include payment information and forwarding instructions, if any.

Hand-delivery and Pick-up of Artwork

Deliver paintings to the Central Library between **12-2 pm on Saturday, April 3, 2010.**

No painting may be removed from the exhibit until the end of the show, **May 1, 2010**

Pick up paintings between 12-2 pm Saturday, May 1. Paintings not picked up will be kept in storage with a \$6/day holding fee.

Any entrant failing to deliver accepted work will be denied eligibility for future SWA Exhibitions.
