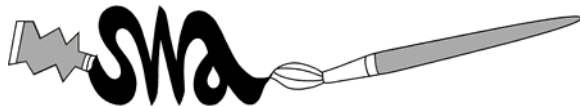

SELECTION and AWARDS

Approximately \$2000
Cash (\$750) and Merchandise

All awards selected at the discretion of the Juror. Pictures of paintings selected will be in the catalogue. A photograph or a CD will need to be submitted of each painting when you enter. Photos/CD's of paintings that are selected for the show will be kept for our library. No slides, please.

ELIGIBILITY

Open to all MEMBERS in good standing of the Society of Watercolor Artists.

WORKS ELIGIBLE

Limited to paintings that are 80% watermedia on paper or watercolor board.
Must be original work completed within the last two years without instructor supervision.
No copies of work, including photographs, by persons other than the artist.
No computer-generated or printed matter will be accepted.
Must not have appeared previously in any juried SWA-sponsored exhibition.
Collage material must be water media on paper. (No commercially colored or printed paper may be used. Paintings must be signed on the face of the painting.

FRAMING

Entries must be suitably framed under PlexiGlas with wire hangers. NO GLASS. Maximum size may not exceed 40 inches in any direction. Frames must be simple and no larger than 1½ inches wide. Works must be matted with white or off-white mats (no black or colors). Any black or colored mats will be disqualified.

LIABILITY

Although the Society of Watercolor Artists and the UNT Health/Science Center will exercise due care in handling works submitted to this exhibition, neither will be responsible for loss of or damage to any work of art.

No painting may be withdrawn before the close of the exhibition. Acceptance in the show gives SWA the right to photograph your work for the catalogue or promotional purposes. Entering this exhibition constitutes agreement with all conditions set forth in this prospectus.

METHOD OF ENTRY

Each artist may submit up to three paintings for Juror selection. No more than one painting per artist will be accepted into the show. A photo or CD with photo(s) of each painting you are entering must be taped on its back in an envelope/baggie with your name, title and whether it is A, B or C.

ENTRY FEE - \$25

This fee is for one, two, or three works per artist. Make checks payable to SWA.

RECEIVING - DELIVERY OF WORKS

Hand deliver all works to the UNTHSC Atrium Gallery, 3500 Camp Bowie Boulevard, Fort Worth, Saturday October 4, 2008, between 12:00-3:00 PM. A completed entry form must be attached to your payment, and a label must be attached to the left hand top of the back of the painting. Entry and label forms plus masking tape will be available on Receiving Day.

PHOTOS FOR CATALOGUE

Attach photo(s) of each work to the back of the paintings in a baggie or envelope, labeled with your name and A, B, or C.

A CD containing photos of all three works may be attached to your entry form and payment. Naming convention for CD files:

- B. Last name, first name, b.jpg
- C. Last name, first name, c.jpg
